	General information on placements 1. Placements will be completed in an environment where the goals set for a study module can be achieved. 2. The supervisor of a placement must be a nurse (2013/55/EU). 3. 1 ECT of placement equals 26,7 hours. The duration of a placement is determined by ECTS. The recommended duration of placements for the Jobiili reservation is marked inside the brackets. The duration of a placement can be affected by RPL and the placement opportunities provided by the workplace. 4. The remaining hours will be the amount completed in the placement. The second semester placement (PRA1005N20S) however, is an exception; the reflections are only 4 hours and thus the hours deducted from the total hours is 8 hours. 5. The number of hours of the work placement will be fulfilled. If there are holidays or sick days during the placement, those will not reduce the hours of the placement. 6.
