#### DESCRIPTION OF THE PROGRAMME

The Master's Degree programmes focus on developing the working life and deepening professional expertise, skills and qualifications. Global Change in Communities is a Master's Degree (90 ECTS) that prepares students for interdisciplinary work that reduces inequalities and promotes sustainable development, health and well-being in communities. The Master's degree programme is aimed at people who work in social services, public health care or the third sector and who are interested in developing communities through sustainable community development, the distinct perspectives of an eco-social approach and through innovative and collaborative leadership.

The degree programme focuses on global change in communities, sustainable development and community-based work and methods. In addition, students can choose from the elective study modules Eco-Social Change and Social Innovation as well as Innovative and Collaborative Leadership. After completing the programme, students will be able to analyse and critically evaluate global changes in communities and develop and promote community-based work and methods. Students will be able to analyse different perspectives of sustainable development as well as the eco-social approach and its relevance to current debates on global, regional and local challenges. Innovative and collaborative leadership studies promote intersectoral leadership and co-creation competences in the field of social and health care services in community development.

#### ELIGIBILITY CRITERIA

Applicants must have a suitable bachelor's degree in one of the following fields to apply: social services, social work, diocesan social work, youth work, nursing, public health nursing and community work. Applicants also need to have at least two years of relevant work experience gained after the completion of their university (bachelor's) degree.

#### PEDAGOGIC IMPLEMENTATION

The study programme is completed online with the help of student and work-based learning environments and collaborative and time-bound learning methods. The language of instruction is English. The programme students can also collaborate with associates from other European universities.

The Master's programme follows the Degree Regulations of Diaconia University of Applied Sciences:

The planned duration of the Master's degree programme (90 ECTS) is 2 years. The studies can be completed in 1.5 years. In the beginning of the studies, students will choose 20 ECTS of elective studies in accordance their personal study and career plan.

Students can choose elective studies in English from the degree programme's available elective modules (e.g. Eco-Social Change and Social Innovation, Innovative and Collaborative Leadership) or from other master's degree programmes.
